Fort Delaware Society Makes History

62 years after its founding by renowned journalist W. Emerson Wilson, the Fort Delaware Society has elected its' first woman president. The election was held at the Society's annual luncheon at the Christiana Hilton on February 5, 2012. Elected President was Catherine "Kay" Keenan. For the last 2 years she has been the treasurer.

Kay succeeds William G. Robelen IV who was president for 18 years. Bill was elected Chairman of the Board to succeed William E. Craven Jr., Colonel Craven has served the Society for 41 years. He has been the Chairman of the Board since 1984. He was President from 1977-1983. He will now become a director once again. His knowledge of the inner workings of the Society are invaluable. The Officers and Directors wish him many more years of service to the Society. Also elected is Vice President Edith Mahoney who has served on the board for 21 years. The new Secretary is Roberta Steele Wilkins. Thomas Smith, the Board Secretary for several years has assumed the duties of the Treasurer.

62nd Annual Luncheon

The Fort Delaware Society's 62nd Annual Luncheon was held on Sunday, February 5, 2012 at the Christiana Hilton. Eighty-two members and guests enjoyed a wonderful luncheon. It was preceded by a "happy hour" where everyone mingled and bid on several items in the Silent Auction.

Thomas Tear, who presented an outstanding program the Spring General Membership meeting, returned, in a fascinating program titled "An Under the Skirt Tour of the Civil War". Accompanying Thomas were Roxanna Hurst and Karen Jessee. The ladies portrayed Thomas' wife and her Aunt Effie. The actors demonstrated what a Victorian woman wore

during the period of the Civil War. They started from the "ground up" showing the undergarments and completed the presentation discussing the outer garment worn at the time. Each piece of clothing was explained as to its use and the material it was made from. Implementation of CAP Recommendations

The Conservation Assessment Plan (CAP) prepared by Lois Price last June contained numerous recommendations. Priority recommendations were the need for gutters and downspouts on the headquarters building and a fire detection system with central monitoring. With the help of State Parks Grant Writer, Kim Johnson, the Society has submitted a grant request to the Delaware Community Foundation.

The grant request uses language from the CAP report to support the request for moisture mitigation throughout the building as well as the need to protect the collection from fire. As Ms. Price reported “The Quartermaster Building is in good condition but lacks gutters resulting dampness and incipient maintenance problems.” Currently there are battery operated smoke detectors in each room. The building has a central monitored burglar system already in place. A central monitored fire detection would add to the safety of the

The Society is also requesting funding from the National Endowment for the Humanities’ Preservation Assistance Grants for Smaller Institutions to address other recommendations such as temperature /humidity monitoring devices for the display cases. Again quoting from the CAP report: “Secure instruments for monitoring temperature and humidity. Pay particular attention to the Storeroom.” Society members have begun the task of moving objects out of the Storeroom to a more climate controlled environment in the building.

Other recommendations which the Board will work on in the coming months are a disaster plan for the headquarters’ building and updating the collections policies.
